

# Eastside Utility Fire Service Water Main Tap Request

This is a request for a Single Fire Service Water Main Tap only. A request for Domestic Water Supply Tap must be made on the Domestic Water Main Tap Request Form. All Water Main Taps will be performed by Eastside Utility District personnel and may be conducted at any time after payment is made. This tap will be made at a location indicated and specified on the Utility Plan(s) or at the nearest appropriate location to the request as determined by Eastside Utility District. A \$400.00 fee must be paid to Eastside Utility District prior to each and every Water Main Tap being performed.

To apply for a Fire Service Water Main Tap, please fill out the form below and submit to Eastside Utility District along with payment for each tap being requested and a copy of the approved drawing(s) after the water distribution plan is approved by Eastside Utility District in accordance with Eastside Utility District Specifications.

A copy of the Application for Special Connection must be completed by the Owner and returned at the same time that payment is made. No taps will be conducted until all approved drawings, applications and forms, and payments are submitted to Eastside Utility District. Taps will be conducted at the discretion of Eastside Utility District on a schedule that does not interfere with general operations or water supply. Construction coordination with Eastside Utility District is the responsibility of the General Contractor or designated Sub-contractor. All taps to Water Main and meter installations will be performed by Eastside Utility District, at the developer's expense, pursuant to our posted specifications for developers. Water Main Taps or Lateral Water Supply Lines that may encroach on State Highway ROW require additional permitting and approvals not directly associated with this office.
